Dear Bishop Humphrey and members of the VA Synod Council:

By this letter, I hereby request that as of _____ (date), you **change my status** on the ELCA Roster to **On Leave from Call** for ONE (1) year. My reason for On Leave from Call status is:

- On Leave from Call (maximum 3 years; renewal requested annually by Rostered Minister)
- Family Leave (maximum 6 years; renewal requested annually by Rostered Minister)
- Study Leave (maximum 6 years; renewal requested annually by Rostered Minister)

On Leave from Call status is approved by Synod Council for ONE (1) year and can be requested annually from Synod Council by the Rostered Minister. **I understand that it is my responsibility to request a change in status to On Leave from Call within 45 days of the termination of my current call and that, if I do not request and receive a change to On Leave from Call status, then I am no longer on the ELCA roster.** I further understand that it is my responsibility to request a renewal of my On Leave from Call status within 45 days of its expiration and that, if I do not request and receive a renewal, then I am no longer on the ELCA Roster.

Wishing still to serve on occasion in a public way (e.g. as a supply pastor, visitation pastor, Bible Study leader, assisting minister, etc.) in the life of the Church, I continue in my promise to abide by my ordination vows, to live in full accord with the conduct of rostered ministers as outlined in *Vision and Expectations*, and to remain current in my boundary training and certification. In whatever ELCA congregation that I join or visit, I also give assurance that I will respect, guard, and support the rights and privileges of the pastor under call by that congregation.
